The "temporary escalation spaces" 2024 guidance states "full environmental assessment (including the assessment of fire hazards and exits)" is required. The 2022 guidance, "reminder of fire safety considerations" provides a methodology for achieving this as well as outlining legal requirements (which will always apply).
